Product Stewardship

U.S. Regulations of Interest

- Food Allergen Labeling And Consumer Protection Act of 2004 (FALCPA)
Verso products do not intentionally contain any of the eight foods or food groups recognized by FALCPA as major food allergens. These include milk, eggs, fish (e.g., bass, flounder, cod), Crustacean shellfish (e.g., crab, lobster, shrimp), tree nuts (e.g., almonds, walnuts, pecans), peanuts, wheat, and soybeans.
- Dodd-Frank Wall Street Reform and Consumer Protection Act
Conflict minerals, as defined in the Dodd-Frank Act, are not intentionally used in the manufacture of Verso products, nor are they necessary to the functionality of these products.
- Consumer Product Safety Improvement Act of 2008 (CPSIA)
Lead and phthalates are not intentionally used in the manufacture of Verso products. Independent testing of representative samples confirms that these products meet the requirements of the CPSIA, specifically they contain less than 100 ppm by weight of lead and less than 1,000 ppm by weight of phthalates (DEHP, DBP, BBP, DINP, DIDP and DnOP).
- CONEG and Toxics in Packaging Clearinghouse (TPCH)
Lead, mercury, cadmium and hexavalent chromium are not intentionally used in the manufacture of Verso products. Independent testing of representative samples confirms that the sum of the incidental levels of these metals does not exceed 100 ppm by weight.

Chemicals of Interest

The chemicals listed below are not intentionally used in the manufacture of Verso products:

- Bisphenol A (BPA)
- Formaldehyde
- Dimethyl fumarate (DMF)
- Phthalates
- Organotins
- Parabens
- Natural rubber latex
- Heavy metals
- Perfluorinated compounds (PFOA/PFOS) containing more than 6 fluorinated carbon atoms

Bleaching Process

Virgin pulps used in the manufacture of Verso products are bleached using an elemental chlorine-free (ECF) process. Recycled fiber derived from post-consumer waste is processed chlorine-free (PCF).

Sustainability

U.S. Lacey Act

All of the virgin fiber used in Verso products originates from North American forests. Verso maintains multiple third-party certifications (Forest Stewardship Council, Program for the Endorsement of Forest Certification and the Sustainable Forestry Initiative). These certifications provide assurance that Verso products are manufactured from fiber that has been legally harvested and procured from well-managed forests.
